

Fun Facts

In the hot summer months up through 1927, kind hearted firemen would often fill watering troughs by the horse hitching rails that stood along Broadway.

"Sparky", a firefighter costumed as a Dalmatian fire dog, frequently interacted with school children in the community.

"Doc" Jacob Rohrer was a local dentist that served as GFD Fire Chief from 1927 – 1953. He is referred to as the "father" of the GFD serving in this role for over 25 years, the longest of any serving in history.

One hundred eighty six years and counting.

That's how long the Granville Fire Department (GFD) has proudly served the Granville community. In 1834, Granville was a thriving community. Since its founding in 1805, the population had grown to 362 residents in the village and 1,421 in the township. There were numerous brick and frame residences, a growing commercial center, three chartered schools, four churches, and a number of industrial ventures. While the community had been spared many fires, the threat was real. A sense of pride and necessity to protect and maintain what had been built spurred the organization of the first "fire department".

The department was manned by uniformed volunteers who used a small hand pulled tank bound by metal bands and 12 leather buckets to put out fires.

We've come a long way over the years. The fire department has continuously adapted and grown with the times as needed. Today, in addition to protecting life and property from fire hazard, the department is responsible for mitigating hazardous material incidents and responding to medical emergencies making over



responsibilities along with community growth. To address, today's department consist of 50 highly trained full and part time members with access to 9 specialty vehicles equipped to handle any emergency situation.

This year marks a special time in the history of the GFD. After serving the community for 83 years from its downtown Prospect Street location, the fire station is being relocated to a green field facility south of downtown on S. Main Street. It was with much debate, careful thought, and detailed planning this decision to relocate was made. The benefits the new station will provide to the GFD and community will make it all worthwhile. Of particular note, the new space will contain all operations under one roof, the ability to get trucks out of the station quickly and easily, improved service and storage spaces, and classroom and hands on training spaces. In addition, the interior was designed with the firemen's health benefits in mind, reducing the risk of cancer causing material exposure. Relocation to the new "state of the art" facility is targeted for October, 2020.

2000 runs per year. The department also provides public education for citizens, inspections of schools and fire drills, approval of building fire-protection systems, permitting and testing of fireworks technicians, fire guards and fire extinguisher servicemen and is an integral part of the Licking County Emergency Preparedness and Disaster Plan (Office of Emergency Management).

The number of "runs" made by the fire department has grown exponentially over the years. This growth has stemmed primarily from the addition of medical emergency response to the fire department's

GFD Historical Timeline:

1834 First organized volunteer "fire department" – utilized small hand pulled tank bound by metal bands with 12 leather buckets for dousing fires.

1885 Granville Hose Company No. 1 was organized as a volunteer fire department of 16 firefighters. The bell atop the Opera House, pulled by hand, served as the community fire bell.

1903 Hose Company No. 1 became Granville Fire Department (GFD). Fire chief position was created and the force size was increased to 20 firemen.

1927 Granville obtained its 1st motorized pumper fire truck ("Old Betsy") with 1500 ft. of hose. An additional 500 ft. of hose was stored at Denison University. An electric fire siren for use as a fire alarm was obtained replacing the Opera House bell.

1937 Fire equipment was relocated to a garage on Prospect Street. Addition of a 2nd fire truck with closed cab was purchased with 700 gal/min pumping capacity and 1000 ft. of hose.

1938 The first Denison students inducted into the department. This tradition continues today.

1949 Public emergency medical services were added to department's responsibilities

1972 New Fire station building was erected in place of original station on Prospect Street. Denison purchased a 1948 85-ft ladder truck for the department.

1974 First female volunteer fire fighters inducted into department (3 female Denison students).

1998 Department replaced the 85-ft ladder truck with a 93-foot ladder truck to more adequately reach the tall buildings on Denison campus.

2007 Transition to the Granville Township Fire Department. Moved from being a volunteer based organization. Hired the first paid fire fighter/paramedic as fire chief. Began robust training program for fire-fighters.

2014 Fifty full and part-time firefighters. Equipment includes 1 fire chief's vehicle, 1 water tanker, 1 engine pumper truck, 1 ladder truck, 1 grass fire truck, 1 pumper rescue truck, 2 emergency medical services vehicles, 1 utility task vehicle (for off-road rescue).

2020 Department relocated to "state of the art" green field facility on S. Main Street, Granville.

1500 TREES FOR LIFE

The First Presbyterian Church of Granville has a goal, "Within the next 5 Years, we aim to plant 1500 healthy, native trees in public spaces in our community to do our part in caring for this place we call home."



The idea came to light during an adult education discussion group at the church on the book "The Gospel According to the Earth" by Matthew Sleeth. The book touts many benefits of planting trees. The obvious, beauty, commu-

nity pride and health to our environment. Studies have also shown benefits go beyond, linking trees and vegetation in a city, to reducing crime rate. From these discussions, along with the Church's pledge of being an Earth Care Congregation, the 1500 Trees for

life project was born. Last fall, as part of a pilot launch, 25 trees were planted near the new Village and Township Service Facility. Trees range in size from 6 to 15ft tall. FRANK PACKARD

PLACING HIS MARK ON GRANVILLE

Between the year's 1905 and 1924, Frank Packard, often referred to as "America's foremost institutional architect" provided Granville with three of the most beloved, beautiful, and appreciated buildings within our community -The Granville Inn, the Granville Public Library and the renovated Bryn Du Mansion. These buildings have stood the test of time and are as beautiful and functional today as they were when Frank first imagined them.

Born in Delaware, Ohio, Frank attended college at the Ohio State University and the Massachusetts Institute of Technology studying Architectural Engineering. He worked and continued to study in several leading architectural firms in New York City before returning to his home in Columbus, Ohio to practice his skills on his own.

In 1899, Packard took over the firm that he and Joseph Warren Yost had formed in 1892. Their work focused primarily on the design of government and university buildings across Ohio and West Virginia. As he moved forward on his own, Packard began to take on the Craftsman style in his designs. In other words, Packard essentially adapted his designs "to the needs of the building materials found on the building site, making the building seem more like a natural formation as opposed to something foreign to the land". Packard used the Craftsman style for each of the 3 Granville facilities. As an example, the stone used for each of the buildings was quarried from local land; for the Bryn Du Mansion and Granville Inn the stone came from the hillside behind the Bryn Du Mansion.

Fun Facts

Frank Packard designed over thirty-four hundred buildings during his career and was recognized by many for his talents. Words like "most prominent", "renowned", "influential", and "leading early 20th century Columbus architect" are often used to describe him.

Additional well known Packard designs include the once famous Columbus, Seneca Hotel; Bexley's, Jeffrey Mansion, the original Columbus Country Club; the Scioto Riverfront Civic Center; and the library buildings for Miami University and Ohio University.



It is of interest to note that Frank also designed two homes in Granville's neighboring Newark - one of which is thought to still be located on Hudson Avenue, north of downtown, and one designed for the long-time Newark department store owner, John J. Carroll. Numerous Packard designs grace the Columbus campus of The Ohio State University including the striking Orton Hall which is still in use today. In addition to having a significant architectural impact on the campus, there is historical evidence to suggest the concept of "the Oval" was spelled out in the first master plan for the campus that was developed by Packard in 1904. As many know, this is a beloved area of the campus and has remained virtually unchanged over these many years.

Sadly, Frank Packard's career was cut short. He died unexpectedly in October, 1923 from a stroke. Neither the Granville Inn nor the Granville Public Library projects where completed at the time of his passing, but others insured that his designs were carried out as originally planned. These buildings stand strong today. While Frank's life was much too short, we are grateful for his work and his amazing architectural designs will live on throughout Granville, Newark and Ohio at large for decades to come.
